# Instructions for Preparing Camera-Ready Papers to IBERGRID2009

**Abstract.** These instructions give you basic guidelines for preparing cameraready papers for the conference proceedings. This is where the abstract should be placed. It should consist of a concise summary (500-1000 words) of the material discussed below.

### 1 Introduction

The Proceedings (ISBN Book and CD-ROM) will contain all the papers and posters (extended abstracts) accepted for the conference. Papers which appear in the Proceedings have undergone the review process of the Programme Committee of IBERGRID 2009. Authors are asked to prepare and submit electronic versions of their camera-ready papers according to these instructions. Poster authors may also submit extended version of their work for publication in the conference proceedings according to this instructions. Accepted conference papers and posters will be also available on the Web, at the IBERGRID web site.

### 2 Manuscript preparation

Papers must be typed in English using a word processor that is able to generate PDF files.

The title of the paper is typed in Arial (boldface 14pt) and centred on the page. The authors name is typed in regular letters and centred on the page (Arial 10pt). Directly under the authors name and also centred is the authors affiliation institution plus e-mail address (Arial 9pt). If authors belong to more than one institution, marks shall be used to establish the correspondence, as in this example.

The abstract is typed in regular letters (Arial 9pt) with a 10mm indentation on each side. The word Abstract. is typed in Arial (boldface 9pt).

Manuscripts must be typed single spaced using 10 point characters. Only Times, Times Roman and Times New Roman fonts are accepted for the text. Section and subsection titles are typed in Arial fonts using 12 and 10 point characters, respectively.

The text must fall within a frame of 12,5 cm x 19,5 cm centred on an A4 page (21 cm x 29.7 cm). Paragraphs must have 5mm of indentation except for the first

line of each section. The paragraphs must be typed without any spacing below. The text of the papers is written in one column and justified. The maximum length of a paper is 12 pages. Do not number the pages. The final format in which the papers will appear in the Proceedings will be a PDF file. Authors are requested to send a PDF file of their final paper to be included directly in the Proceedings, so please follow these instructions carefully.

#### 2.1 Figures and tables

Figures and tables should be centred in the text, numbered consecutively throughout the text, and each should have a caption underneath it (see for example Table 1). Care should be taken that the lettering is not too small. All figures and tables should be included in the electronic versions of the full paper.

#### 2.2 Equations

Equations should be typed within the text, centred, and should be numbered consecutively throughout the text. They should be referred to in the text as Equation (n). Their numbers should be typed in parentheses, flush right, as in the following example.

### 3 Electronic Submission

The submission process for IBERGRID2009 should be done on the conference Web site. A PDF version of your final paper is required. It should be expected that after your submission, your paper is published directly from the file you send without any further proof-reading. In addition authors should post or fax to the conference secretariat a signed transfer of copyright form. Further instructions are given on the Web site.

# 4 Best Paper Award

Student authors wishing to apply to this award must declare it in the form at the Web site, when submitting their papers. Further instructions are given on the Web site.

The acknowledgement for funding organisations etc. should be placed in a separate section at the end of the text.

The list of references should be ordered alphabetically according to the first author surname. All references should be cited in the text, and using square brackets such as [1] and [2,3].
